Food establishment licenses issued by the City of Keene are annually renewed for September 30th. Renewal applications, instructions and invoice will be mailed to establishments holding a current license in August of each year.

For renewal applications, please send this application with check payable to the CITY OF KEENE to:

All renewal applications must be received prior to October 1st for the next cycle year.

Late renewal fee: in addition to the appropriate class license fee, there will be 1/12 of the annual fee per whole month late added for any renewal applications received after October 1st.

For purposes of determining seating capacities for drive-in food service establishments, each car space provided shall be counted as the equivalent of five (5) seats.

The Health Official shall have the final say in determining which category is applicable to an individual food service establishment.

The City of Keene is a self-inspecting municipality with unscheduled, periodic inspections conducted during the course of the year. Information on the City of Keene adopted food ordinance can be found online at:
